

RESOLUTION 89-1132

1 A RESOLUTION OF THE BOARD OF COUNTY  
2 COMMISSIONERS OF BROWARD COUNTY, FLORIDA,  
3 DELEGATING TO AND CONFERRING UPON THE  
4 CITY OF FORT LAUDERDALE, FLORIDA, THOSE  
5 POWERS CONFERRED UPON BROWARD COUNTY BY  
6 CHAPTER 163, PART III, FLORIDA STATUTES,  
7 THE COMMUNITY REDEVELOPMENT ACT OF 1969,  
8 AS AMENDED, SUBJECT TO THE BOARD'S  
9 REVIEW AND APPROVAL OF THE COMMUNITY  
10 REDEVELOPMENT PLAN.

11 WHEREAS, The City Commission of Fort Lauderdale,  
12 Florida, is desirous of utilizing the community redevelopment  
13 powers specified in Chapter 163, Part III, Florida Statutes,  
14 the Community Redevelopment Act of 1969, as amended; and

15 WHEREAS, pursuant to Section 163.410, Florida Statutes,  
16 said City Commission has officially requested the Board of  
17 County Commissioners of Broward County, Florida, to delegate  
18 and confer upon the City Commission of Fort Lauderdale,  
19 Florida, the authority to exercise all of the powers, and to  
20 be subject to all of the responsibilities of the Community  
21 Redevelopment Act of 1969, as amended, for the purpose of  
22 establishing a Community Redevelopment Agency for the  
23 rehabilitation, conservation, or redevelopment of blighted  
24 areas within the municipal jurisdiction of said City; and

25 WHEREAS, the Board of County Commissioners of Broward  
26 County desires to delegate to the City Commission of the City  
27 of Fort Lauderdale, Florida, those powers conferred by the  
28 Community Redevelopment Act of 1969, as amended, subject to  
29 the Board's review and approval of the Community  
30 Redevelopment Plan; NOW, THEREFORE,

31 BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF  
32 BROWARD COUNTY, FLORIDA:

33 That the Board of County Commissioners of Broward  
County, Florida, hereby delegates to the City Commission of  
the City of Fort Lauderdale, Florida, the authority to create  
a Community Redevelopment Agency to operate within the

1 jurisdiction of that city, and the authority to exercise all  
2 those powers conferred upon local governments by the Com-  
3 munity Redevelopment Act of 1969, as amended, subject to the  
4 Board's review and approval of the Community Redevelopment  
5 Plan.
