

FIRST AMENDMENT TO CONTRACT NO. 202-10621 BETWEEN THE CITY OF FORT LAUDERDALE AND BRANDANO DISPLAYS, INC.

WHEREAS, the City of Fort Lauderdale, a Florida municipality, ("City"), and Brandano Displays, Inc., a New York corporation authorized to transact business in the State of Florida, (Contractor), entered into Contract No. 202-10621 dated November 8th, 2010, to provide to the City holiday and centennial decorations ("Contract"); and

WHEREAS, the City and the Contractor wish to extend the Contractor's provision of a centennial monument sign pursuant to the terms of the Contract during the period March 16th, 2011, through September 1st, 2011,

NOW, THEREFORE, as an amendment to the Contract, the City and the Contractor hereby agree to as follows:

1. The Contractor shall provide to the City the centennial monument sign display as described in the section titled Display Area #5: Centennial Monument Sign of the Scope of Services of the Contract during the period March 16, 2011, through September 1, 2011, in accordance with the terms and conditions of the Contract and the letter dated March 16, 2011, from Patrick Brandano to Earl Prizlee, a copy of which is attached hereto as Exhibit "A" and incorporated herein.

2. All other terms, conditions, and specifications contained in the Contract remain unchanged.
