

AMENDMENT TO SMART CARD PARKING PAYMENT SERVICE AGREEMENT
BETWEEN PXT PAYMENTS, INC., F/K/A PARCXMART TECHNOLOGIES, INC., AND
THE CITY OF FORT LAUDERDALE

THIS Amendment to Smart Card Parking Payment Service Agreement, made and entered into on the 7th day of June, 2012, ("Effective Date"), is by and between the City of Fort Lauderdale, a Florida municipality, ("City"), whose address is 100 North Andrews Avenue, Fort Lauderdale, FL 33301-1016, and PXT Payments, Inc., f/k/a Parcxmart Technologies, Inc., a Delaware corporation authorized to transact business in the State of Florida, ("Contractor"), whose address 300 Brickstone Square, Suite 201, Andover, MA 01810.

WHEREAS, the City and the Contractor entered into an Agreement for Smart Card Parking Payment Services, dated July 22, 2008, ("Contract"); and

WHEREAS, during the next six months the Contractor will refund to cardholders the unused value of their Smart Cards,

NOW, THEREFORE, the City and the Contractor hereby amend the Contract as follows:

1. Effective immediately, the City and the Contractor will discontinue the sale of Parcxmart cards referenced in Subsection 2.b. of the Contract.

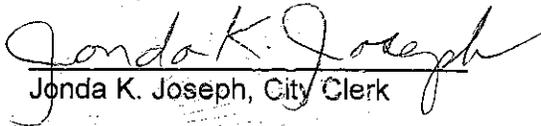
2. The City will continue performing its data collection, download, and transmission activities pursuant to Subsection 3.a. of the Contract for a period of six months from the Effective Date of this Amendment, after which period such activities shall cease.

3. The Contractor will continue making payments to the City pursuant to Subsection 3.b. of the Contract until all payments associated with Subsection 3.a. of the Contract as amended by Section 2 of this Amendment have been made.

4. Except as provided in Subsection 5.d. of the Contract, the Contract shall terminate six months after the Effective Date of this Amendment.

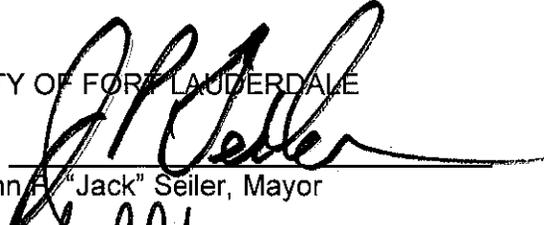

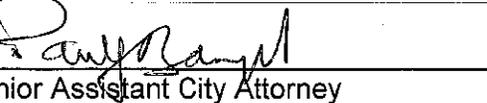

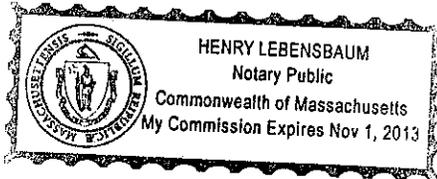
