

**SECOND RENEWAL TO AGREEMENT**

THIS IS THE SECOND RENEWAL TO AGREEMENT, made and entered into this 5th day of April, 2011 by and between:

CITY OF FORT LAUDERDALE, a municipal  
Corporation of the State of Florida,  
(Hereinafter referred to as "CITY")

and

THREE-H LEARNING CENTER, INC., a not for profit corporation  
organized under the laws of Florida, whose principal place of business  
is 36546 Thornhaven Lane, Dade City, Florida 33523, (hereinafter  
referred to as "THREE-H").

WHEREAS, the City Commission of the City of For Lauderdale, Florida at its meeting of May 19, 2009, authorized the proper officials by motion to execute an Agreement between THREE-H and CITY authorizing the performance of services in connection with utility maintenance in public rights-of-way; and

WHEREAS, the Agreement authorizes renewal on an annual basis upon mutual consent of the parties; and

WHEREAS, CITY wishes to retain THREE-H to provide, and THREE-H desires to provide services to CITY for an additional one (1) year period until May 18, 2012 in the not to exceed amount of Two Hundred Fifty Thousand Dollars (\$250,000.00); and

WHEREAS, on April 5, 2011 by motion, the City Commisison authorized the proper City officials to execute this Second Renewal to Agreement to extend services under said Agreement until March 18, 2012 in the annual not to exceed contract amount of \$250,000.00;

NOW, THEREFORE, the parties hereto, in consideration of the mutual covenants, agreements, terms, and conditions contained herein, do agree as to the following:

Section 1. The foregoing recitals are true and correct and are made a part of this Second Renewal to Agreement.

Section 2. That the Agreement between CITY and THREE-H entered into on May 19, 2009 is hereby extended under the same terms and conditions, for an additional one (1) year period, said term expiring on May 18, 2012.
