

**THIRD RENEWAL OF AGREEMENT

THIS IS A THIRD RENEWAL OF AGREEMENT, made and entered into this \_\_\_\_\_ day of May 20, 2014 by and between CITY OF FORT LAUDERDALE, a Florida municipality, ("CITY"), and E SCIENCES, INCORPORATED, a Florida corporation, ("CONSULTANT").
