SECOND EXTENSION TO AGREEMENT

THIS IS A SECOND EXTENSION TO AGREEMENT, made and entered into this 28 day of July 2009 by and between:

CITY OF FORT LAUDERDALE, a municipal Corporation of the State of Florida, (hereinafter referred to as "CITY")

and

Corzo Castella Carballo Thompson Salman, P.A. (C3TS), a Florida Corporation, (hereinafter referred to as "CONSULTANT")

WHEREAS, the City Commission of the City of Fort Lauderdale, Florida at its meeting of June 20, 2006, authorized the proper officials by motion to execute this Agreement between CONSULTANT and CITY authorizing the performance of services in connection with a continuing contract for Bridge Designing Consultant Services; and

WHEREAS, Section 6.1 of the Agreement authorizes a renewal option for three (3) successive one (1) year terms upon mutual consent of the parties; and

WHEREAS, on January 6, 2009 (M-13), by motion, the City Commission authorized the proper City officials to execute a Second Extension to Agreement, to extend the term of the agreement to June 20, 2010; and

WHEREAS, CITY wishes to retain CONSULTANT to provide, and CONSULTANT desires to provide, contracted services to CITY for an additional one (1) year period until June 20, 2010, utilizing the contract prices of the original Agreement;

NOW, THEREFORE, the parties hereto, in consideration of the mutual covenants, agreements, terms, and conditions contained herein, do agree as to the following:

Section 1. The foregoing recitals are true and correct and are made a part of this SECOND Extension to Agreement.

Section 2. That the Agreement between CITY and CONSULTANT, dated June 20, 2006, is hereby extended under the same terms and conditions, for an additional one-year period, said term expiring on June 20, 2010.

Section 3. In all other respects, the original Agreement between the parties dated June 20, 2006, and any preceding amendments not in conflict herewith, are hereby ratified, reaffirmed and shall remain in full force and effect as provided by their terms.
