PUMP-OUT AND FUELING: Pump-out services are complimentary to the public at the City marinas. Fueling by truck is available at one designated slip on the New River. This service is complimentary to vessels currently docked at the City marinas; all other vessels are subject to be charged the daily dockage rate. Please call the New River office at 954-828-5423 to make fueling arrangements.
