## C. Review Internal Affairs Investigations

### 1. IA Case 18-015

Complainant: Chief Rick Maglione  
(IA Case 18-015)

Allegation: 1) Knowingly making or signing any false or inaccurate statement in any official investigation, report, or record, or attempting to cause another to do so.  
2) Feigning or exaggerating sickness or injury.

Officer: David Mollinea

Disposition: 1) Sustained

Complainant: Chief Rick Malone  
(IA Case 18-033)

Allegation: 1) Neglect of duty prohibited – neglect in promptly and diligently attending to an discharging the duties of office.

Officer: Daisy Loveras

Disposition: 1) Not Sustained

**Motion** made by Mr. Borwick, seconded by Lt. Stone, to concur with the disposition as not sustained in IA Case 18-033 regarding Officer Gregory Fautas.

Chair Currie asked why Sgt. Karen Dietrich was not listed as the complainant on the issue. Sgt. Malushi stated the complainant is typically the Chief of Police in this type of case.

Chair Currie asked the reasoning behind “not sustained” as the disposition. Major London stated the audio was truncated and was not an accurate accounting of time, so did not provide evidence.

Chair Currie asked if there was something that could be done by FLPD or BSO to fix that issue in the future. Sgt. Dupree stated the request had been made.

Chair Currie stated there seemed to be a lot of drama on the shift, and she thought it was important the officers be above that. Mr. Borwick asked about the relationship between the officers, and Mr. London stated he addressed the issue with the Shift Commander.

In a voice vote, the **motion** passed (5-0).

The next meeting is November 12. Chair Currie verified all Board members could access the meeting files.

With no further discussion, Chair Currie adjourned the meeting at 6:11 p.m.
